2-OLD BUSINESS

A. Discussion on Lifeliners. There were 19 new Lifeliners as follows: Arizona - 1, New Jersey – 14, New York – 2 and Pennsylvania – 2.

There were no new Cans. 35 Starter Kits were sent out in January including 2 going to prisons and we had 13 new Group Information Forms received back as follows: 2 from Phoenix, Arizona and 1 each from Anaheim, California, Apple Valley, California; San Rafael, California; Miami, Florida; Waikoloa, Hawaii; Stevensville, Montana; Las Vegas, Nevada; Roseburg, Oregon; Redmond, Washington; Coquitlam, British Colombia and North Vancouver, British Columbia.

B. National Hotline. John C. gave the report. 186 calls came into the Hotline in January 2007 compared to 1,210 calls coming in January 2008. Total calls are up by about 600.
