1- A. The minutes of the Board of Regents meeting of March 16, 2007 were read and approved. Motion seconded and passed For-7 Against-0 Abstained-0

B. The Operating Statement for March 2007 was read and approved. Motion seconded and passed For-7 Against-0 Abstained-0

2-OLD BUSINESS

A. Discussion on Lifeliners. There were 2 new Lifeliners, one each from Kentucky and New Jersey.

The Board will request at the Trustee meeting that the Trustee Officers announce that all local Intergroup websites remove the G.A. Logo from their websites.
