NEW BUSINESS

A. DAY AT A TIME BOOKS.

The International Service Office does not own the rights to the A Day at A Time books. Karen H. gave a history of the publishers and how the books have been printed over the years. Hazelden Publishing currently owns the rights to the book. Gamblers Anonymous I.S.O. and Hazelden Publishing have a written agreement that there will be no changes without prior approval of Gamblers Anonymous. Also in the signed agreement, Hazelden has agreed to withhold its name from the outside cover of the book. The recent shipment of 500 books was received with "Hazelden Publishing" on the spine of the book and an additional page at the end of the book to which the International Service Office objected. Hazelden apologized and will remove the extra page on future printings. The I.S.O. employees will remove the extra page from the 500 copies already received. Hazelden Publishing has extended a discount for the 500 books already received and offered an additional discount on future copies until the books that were incorrectly printed have been exhausted. Hazelden Publishing will also remove the extra page on the remainder of books in their possession.

The collection in the amount of \$23.00 was taken and the meeting closed with the Serenity Prayer at 10:30 A.M. The next meeting of the Board of Regents will be held January 16, 2016 at 9:30 A.M.
