### OLD BUSINESS:

(1) <u>Big Book Discussion</u>. Letter of March 22, 1976 was read, and it was the opinion of the B.O.T. that the Chairman of the B.O.T. should follow this up with the attorney with the suggestion made to paragraphs 1 & 3, and pages mentioned.

Mention that the reference made to the 12 Steps recovery & unity be made to the explanation of the 12 steps of recovery & unity. Not to the 12 steps of recovery & Unity specified and reference made to the personal stories of the explanation of the 12 steps or recovery & unity, not the personal stories of compulsive gamblers.

(2) Conference Report and Discussion.

First International Conference of G.A.

Dear Brothers: April 1, 1976

This is our seventh bi-annual report regarding the 1977 Conference. Chicago has been hard at work putting together an informative and educational program for all of G.A. It is our intention that here – at Cherry Hill – we shall be able to finalize the G.A. program and be able to return to Chicago to implement the Gam-Anon program with ours and present a full, complete program at the Pittsburgh conclave in October.

To date, as you will note on the attached financial sheet, we have approximately 94 couples, plus children, already having made reservations. Based on a projection we made two and one half years ago, that is about 20% of the projected attendance. We have had communication with all representatives for the past six months and expect that in Cherry Hill we shall be supplied with enough ideas and suggestions to complete the program.

As a trustee who may not have been involved in the program planning, we still need your assistance in promoting the deposits from members in your area. Now is the time to really push this idea. We suggest a \$25.00 original deposit with monthly payments of \$10.00. You can see by the figures that this would at least have the member half-paid upon a Plan A program. Therefore, if he can do so, making the monthly installments, he would have the total amount paid in prior to the Conference.

Chicago intends to provide the dinner speaker for the banquet night and also provide the format for the candle-lighting ceremony. A preview for the Trustees of the program and the facilities has been planned for April, 1977.

Thank you for your past assistance. We look forward to additional help for the next fifteen months.

Motion – add the word "honesty" to step 12 of unity after "anonymity".  $2^{nd}$  – Bob F. For – 11 Against – 10 Not 2/3 defeated.

Step 11 of the Unity Program, 6 months trial of selected few to go full face on press, radio, films and television. Show of hands should there be a change to Step 11 of the Unity Program.
