9. Report on Big Book New 1st Ed. The Gamblers Anonymous Book. The idea of producing a completely new Gamblers Anonymous Book was first considered in July of 1977. The Board of Trustees of the Fellowship discussed the project at the 20th Anniversary International Conference held in Chicago, Illinois. It was generally agreed that an original approach would be needed to present all segments of our program. The Board also felt the book should be written in a structured and interesting fashion and include all relevant data. At this meeting the Board of Trustees voted in favor of the project and then formed a committee to get the word out to all members that submission of fresh ideas and material would be everyone's responsibility.

The book remained in the planning stage until it was decided that the actual writing should be left to professionals. The firm that was selected gathered basic information by attending meetings, reading our literature and interviewing many of the people who contributed to the book. Approximately three years of weekly meetings between the writers and the committee then followed, as it immediately became apparent that constant input from the fellowship would be required. Almost seven years after the first dicussion by the Board of Trustees the book has become a reality.

Gamblers Anonymous would like to thank everyone who helped in developing and producing the book. A special thanks to members of Gam-Anon and the professional community who made numerous contributions.

We believe that the aims and purposes of the Gamblers Anonymous Fellowship have been maintained and advanced through the development of this volume. Committee voted no further payment to Mr. Johns of the writers allowance Inc. Committee to gave list of names and letter of thank you letter to National Service Office for free Big Blue Book 1st, Ed., for those people who helped on the New Big Book 1st, Ed. not to exceed 50 copies.
