OLD BUSINESS:

 On page 17 of the Combo Book, item #3 will be changed to read:

This includes buying from the stack market, commodities and options, buying or ploying lottery tickets, raffle tickets, flipping a coin, or entering the office sports pool.

Also, the Board asked all the Trustees and alternates to write follow up letters to both Pete and Howie, asking them to get together to work things out.
- 2) A member of the Foll River, MA. group was present of the convention and he was good enough to come to the Board of Trustee Meeting and answer questions that the Board put before him. He said that the Foll River meeting reads G.A. and A.A. literature of their meeting, and A.A. literature is on their table. After o long discussion, the Board of Trustees voted to reinstate the Fall River, MA. group to "in good standing".

- 11) The Board of Trustees had a long discussion on a Combined Cocaine Addiction and Gamblers Anonymous: The Board says that anyone can speak on whatever they wont to in their therapy in a Gamblers Anonymous meetings.
- 12) This was dropped from discussion, as no motion was made on this idea.
- 13) The Board of Trustees drapped this subject from the agenda as it is gambling, and it is covered in the definition of gambling.
- Discussion was held to change the front and back covers of the Combo Book. Motion was made to eliminate the words G.A., and the reduction in size of the words. Passed first vote.
- 15) Trustees from Canada complained that it takes too lang for them to get the mail, and then return it for the mail meetings. Motion was made and passed to let the Chairman of the Board of Trustees use whatever means is most expedient and best and then get reinbursed from the National Service Office.
- (16) Regarding Hazeldon printing of "What is G.A.", they are on independent printing company, and we had nothing to do with their printing, but they had a verbal o.k. from the Chairman of the Board of Trustees.
- 17) After a short discussion the motion was defeated.
- 18) In a mail election, the Chairman will send a self- addressed return envelope to the voting Trustees and Alternates marked "Ballot". after all envelopes are returned they will all be opened at the same time.
- 19) The Board of Trustees, after a discussion, feels that a mini--conference should be flexible enough that they should not need to be near a notional conference, but it still is up to the discrepency of the mini-conference to set the dates for their conference.

International Directory:

The size and printing of the 1986–1987 Directory is excellent. The Trustees and Alternates ore responsible to get the new meeting places and the closing meetings, and all pertinent in formation concerning the Directory, to the National Service Office.

Discussed the letter sent from A.A. to the National Service Office, about putting a disclaimer in our Big Book. After a long discussion and acknowledging that we did take some literature from A.A., we agreed that it is a legal problem, and we are going to get legal advice on what plan to follow.

The two Assistant Chairmen of the Board of Trustees should have the agenda before time, and have it clarified to bring to the Board of Trustee meeting.

Discussed Australion situation: Gamblers Anonymous in New Zealond is having a problem with a psychologist, Dr. Kemp, who says that he is representing Gamblers Anonymous and is charging people for office visits. The Board of Trustees voted to send a letter to Dr. Kemp, asking him to please cease from using the Gamblers Anonymous name. The Board also agreed to send a letter to the New Zealand group, letting them know that we are in accord with them. The Board will also give them a letter stating our position in this matter, that they can bring to the newspaper to print.

The new Dear Judge Letter was read by the Chairmon, and was gone over and corrected as he read it. It was passed and given to the Literature Committee to bring to the conference in Palm Springs for a second vote.

Discussion on Changing the voting procedure by the Boord of Trustees on making literature changes in the Combo Book, any literature, Guidance Code, from two votings to one. There was no motion made on this.

Trustee meeting was ended on Friday, May 30, 1986 at 6:15 P.M., with good and welfare by all the present Trustees and Alternate Trustees and past Board members present. Also by the the National Executive Secretary, the two Vice Chairmen of the Board of Trustees, and by the Chairman of the Board of Trustees.

Collections of the four meetings totaled \$439.00, which was given to the National Executive Secretory to take to the National Service Office.
