My name is Ed K. I am a compulsive gambler and a Trustee from Area 1. I placed my very last bet December 29th, 2002.

I thought the mechanics of the Trustee Meeting in Kansas City went very well. I enjoyed hearing from many of the Trustees on the issues that are important to them. Whether I agree or not I've been taught, and I take it seriously, to listen to what each person has to say.

I thought the election process could have been handled better and I will be submitting an agenda item for Montreal to streamline the election process. Essentially the idea will be that the bottom accumulated 25% of votes counted is the dividing line where the candidates would be dropped off. Of course the exception will be when we are down to three candidates and the two bottom candidates are tied. Then a runoff of the bottom two is still in order.

The most distressing part of the Trustee meetings, in general, is the slowness to accept change in our Combo Book. Especially when the basis is "back when I came in [20+ years ago] this worked for me, it's what I like and it should not be changed". The reality is the world is changing. Younger and younger new members appear every day. Our retention rate has not improved in the last six years (or in 20 plus years by some accounts). I was taught in recovery if something is not working, make a change. I hope to live to see the day that the most commonly read piece of literature (our Combo Book) is viewed as a living document rather than a static piece of literature. I also hope to see more new literature: especially in the area of steps and sponsorship. We need to attract and retain new members by giving them something they can relate to.

During the discussion of removing the words, "mink coat," I almost had to ask

for a point of information. I'm not so sure that those of my generation and those after know what a mink coat is. All kidding aside, I perfectly understand both arguments in regards to some of the updating of terminology. However, I must say, I don't believe that because we use mink coat instead of private jet, that members my age and younger don't get the message being delivered. We may have some younger members coming into the program, but we are not completely idiotic.

What happen to sharing our experiences??? I have never had any person in the room ask me what a mink coat is. Maybe that means regardless of age, we get it. They weren't going to find ways to dumb down the program for me. It was time for me to decide if I wanted to grow up. After making that decision, I became a sponge off the members in my area. If I didn't know something in a piece of our literature, I simply asked. This is what helped me to understand that despite the age differences or materials that we desired, gambling was completely destroying my life the same way it destroyed theirs many years before me. I then realized that if I could listen to the experiences and ask when I wasn't sure, that maybe just maybe I wouldn't have to go through the same devastation as the elder members in my area.

Thank goodness I learned this a while ago because many of these members in my area continue to help me live life without gambling despite the blows that continue to come.

I believe that like most people that don't continue to come, the young person that doesn't come back is not staying away because of the verbage in our literature, but because they are just not ready to grow up and face life.

Hi all,

Howie C. again, getting back to make comments on what some of you wrote. Matty saying we should have a G.A. meeting at the conferences: I'm "assuming" that he's referring to an "official" meeting, such as we have in most parts of the U.S. and Canada. They do have what is called a therapy room at the conventions, but it's not run like a regular G.A. meeting. Matty, for the past few years, this has changed at the conventions. We used to have the traditional type of G.A. run, with different people in charge for an hour at a time. I would guess that about 4 or 5 years ago that changed. My guess as to why it changed is because in some parts of the country, G.A. members just sit around and talk, they don't have what most of us are used to. The way to get it back is very simple as far as I'm concerned. All the convention committee needs to do is to incorporate it into their program, but it must be done with people who will comply and be responsible. To have an obligation from certain people to be there for an hour (or two) at 3 or 4 times during the course of the weekend. These peoples obligation would be the exact same as it is for people doing workshops. So, if it's to be, it's up to the convention committee to make sure that it gets done. I agree with you about the Good and Welfare, but it has to be controlled in the same manner as the rest of the Trustee meeting. But for the Good & Welfare, no more than 2 minutes per person.

Ed K.-- You said that you'd like to see more literature on the steps and on Sponsorship. I agree with you about the literature for the Steps, but I think we have a couple of wonderful pieces of literature for Sponsorship. I use the Sponsorship literature twice every 6 weeks where I work, and I think that if people would just utilize what we have now, it would be great. One of my biggest complaints is that (Estimate) 90% of our membership does NOT read our literature. Even many of our Trustee's are not up on all of our literature. I hear a lot of compliments about my knowledge of the G.A. program. If I have more knowledge than any other member, it's ONLY because I read the literature that we have. I have done this since I was very new in the program, because I was "forced" into involvement, or G.A. in my area would have died again, like it did for the 12 years off and on, prior to my first attendance. And I wanted to always do it the "G.A." way. Also with the new addition that Richie S. got passed in Kansas City, it will enhance what we have now. But personally, I don't think we need anything more than what we have at this time. Maybe someone will write something that's real good, and I would be all for it. We can't have too much literature available, and we really have very little on the Steps, as well as other things.

Dina: I love your openmindedness about the program. You have had the benefit of coming into the program as a very young woman, and now you're progressing to becoming an "elder statesman". Your experience on both levels is very important to both the newer and "older" members. I hope you continue to express yourself as you do. And thank you again for jumping up at the Trustee meeting to make my point of information for me. Due to the fact that I feel it's not right for a past trustee not to be able to make a point of information, I'm going to have to run for Trustee again. I like to let others be involved, since I'm going to be there anyway, but I guess (if I get elected) that one less person will be involved at the Trustee level.

Rules and Procedures - A Way of Life in Trustee meetings

Nightmares like that could be hazardous to anyone's health. So we are now looking at a spaghetti western similar to 'The Good, The Bad and the Ugly'.

The Good is that is was glorious that 14 people wanted to run for the 1st Co-Chair.

The Bad is that we can only elect 1 person for that position and the other 2 of Chair and 2nd Co- Chair.

The Ugly is the unmistakably flawed election process.

In 2011, we get to do it again. Who knows, maybe 20 people will accept the nomination for any one of those positions. It's time to take 'the ugly' and send it to charm school. In short, we need to fix this. I have put an item on the agenda to detail everything about the election process and am hoping that someone has a better way of doing some of the 15 steps I outlined. I will be very glad to consider the suggestions and change them with an updated agenda item, which can be done at any time up until the 60 day deadline for agenda item submissions, which by the way is coming up in 3 months from today.

Please be sure to look at the detail, but realize that with the detail comes the mechanical aspect of how all the elections would run and not be subject to the whim of the Chairman, whomever that may be in the future. You all have my contact information...let me know if you think any part of it needs improvement. Let me handle the objections now and make the necessary changes so we don't argue on the floor in Quebec. I am quite sure that everyone is convinced the election process is broken. Let's all work to make this agenda item stronger and not be a big load in Quebec.

Here is the new procedure listing I am hoping to have approved:
Rules and Procedures - Executive Board - Procedure For Elections

Remove current procedures for election of the Chairman and Co-Chairs and replace with the following:

Election Procedures

- 1) - The Chair will open up the floor for nominations for each office individually as each office is filled. A person can nominate him/herself. No seconds will be required. There will be no limit to the number of nominations that will be accepted.
- 2) - When there are no more nominations, the Chair will close the nominations.
- 3) - The Chair will read the nominations to the room
- 4) - The Chair will ask each nominee to declare their intention from the nomination process.
- 5) - The Chair will read the list of those nominees who have accepted the nomination and become part of the ballot.
- 6) - Each current Trustee will select one person out of the candidates' names to write on a ballot. If more than one name is written on any ballot, the ballot will be invalid and not counted.
- 7) - The ballots will be counted by 3 GA members, selected by the Chair, (added after Herb's remarks) who are not Current Trustees or listed on the ballot.
- 8) - If any one candidate receives more than 50.0% of any votes, that person will be the elected individual for that position, if not,
- 9) - The Chair, or a designated person if the Chair is running for office and still in contention for office, will announce the top 3 names of those candidates who received the most votes and who will be on the 3-candidate ballot.
- 10) - If there are candidates that are tied in any one of the top 3 positions, so as to increase the total number of candidates in excess of 3, a qualifying ballot will be taken to reduce the number of candidates to 3, where the remaining procedures will take effect.
- 11) - Each current Trustee will once again select one name out of the 3 remaining names for the ballot.
- 12) - If no one candidate has received more than 50.0% of the vote, the candidate receiving the lowest vote will be eliminated and a final vote will be taken.
- 13) - A final vote between the 2 remaining candidates will decide the winner for that position.
- 14) - Any vote resulting in a tie will be redone until such time as there is no tie.
- 15) - If after the 3-candidate ballot, there are 2 candidates with a tied number of votes and 1 candidate with less than that amount. The 2 candidates receiving the tied number of votes will comprise the final ballot.
- 16) - If after the 3-candidate ballot there is 1 candidate with the most votes, but not a majority and 2 candidates with a tied number of votes, a runoff ballot only between the tied votes will be taken to ensure a 2nd candidate to be listed for the final ballot vote against the candidate who received the highest number of votes. Election Process:

David's procedures for the election of the Chairman and the 2 co-chairs of the BOT look good. The procedures should specify who will appoint the 3 members who will count the ballots. Either the current Chairman or perhaps the Executive Secretary or even perhaps the Chairman of the BOR.

The executive Secretary should bring prepared blank ballots for the election instead of torn paper of different sizes and colors.

I have share that I couldn't have done it without the sponsors I have had over the years and why they have changed. I keep hearing I am too new, too sick, or I am not new anymore. The combo book is great and I get different messages from it every time I read it. The towards 90 Days book literally got me through my first 90 days, which I read daily, and I share that too. How do you express the need for sponsorship? Why does our literature stress that sponsorship is for the new person? I still need a sponsor with almost 9 years clean. Am I just sicker than everyone else?

I think the combo book is really lacking on the topic of sponsorship. I can't tell you how many times I have heard "if it was important it would be in the combo book (well, more than a couple words on page 17)." I brought it up to our Inter-group a few months ago and they agreed. We started working on an agenda item but it wasn't ready for Kansas City. The one member that didn't like what we had said it should be a whole page but didn't have any suggestions as to what it should say. I haven't forgotten the item. Looking for some input. I tried to convey the message to a member at the meeting have the meeting last Friday and just wasn't getting through.

Good morning, Carol -

I hear your frustration and understand what you are attempting to say and do. I am amazed and thankful we were able to add a new #6 to page 17 to; GET A SPONSOR. IT IS DIFFICULT TO RECOVER ON YOUR OWN.

Since there appears such aversion to adding anything to the Combo Book, perhaps after reading our Combo Book, the secretary or chair could go around the room and ask each person what sponsorship means to them. I know some of our meetings do that with the 20 questions which allows each person to recall what those feelings meant when they first entered the room; thereby "continually reviewing the 20 questions."

Like you, I believe sponsorship is one of those critical ideas to our recovery that remains an unknown to many members, both new and senior. I've heard some say that sponsors "only" work the Steps with a member (I think that's an old AA tradition); some say a sponsor becomes your best friend (more of a GA concept); but I think the relationship has to be agreed upon between what the sponsee wants and what the sponsor is willing to provide.

The "Gamblers Anonymous Sponsorship Manual" and the "Short Term Group Sponsorship Approach to Helping the New Member," which contain some information are nonetheless weak in some areas. After having gone through these in depth at a workshop on sponsorship, I was asked by an attendee (not a new member), "but what DOES a sponsor actually DO?"

At some meetings in San Diego, groups read from other literature: "Toward 90

Days," a page from a step in the red book, "A New Beginning." If sponsorship is one of your community goals, then perhaps at every meeting, someone should read a paragraph or a page from the "Sponsorship Manual" to remind everyone (both new and senior) what sponsorship could mean to their recovery?

I offer these only as suggestions - and I hope you get many more positive suggestions on what you can do to assist your area in the importance of sponsorship.

Carol,

I take a completely different posture on what you have written. First of all, the centers of wisdom in your rooms need to understand the word 'axiom'. Just to help out, it is a statement that is regarded as being established, accepted, or self-evidently true. So you can tell these 'GA Gurus' to put that statement of 'if it was important it would be in the combo book' where the sun doesn't shine. I don't think I have heard a more ignorant statement in my years in the program. I've heard many other statements that compete for equal billing, but that speaks volumes for the recovery of those who live by it.

Okay, I feel better now having gotten that out. My belief is that the Combo Book is like daily medication someone would take to maintain a condition. It's like the eye drops for glaucoma. You take them everyday to keep from going blind, but taking them doesn't make the condition go away. We are compulsive gamblers. The Combo Book is the tie that binds us. It is constant reinforcement. Sponsorship can be mentioned, but that is a subject of a more personal basis.

We read our other literature to widen our once narrow minds to life and certainly to recovery. The entire sponsorship issue is a fault of your room(s). We have our vice-secretary assign sponsors. Anyone with 1 year of abstinence gets put on the list for availability and the list is evenly disbursed. The booklets should be topics for meetings. Force the issue and it will gain some traction, but I repeat, it must be forced, because many do not want to do this. It is a necessary part of recovery, and those who resist sponsoring others, need to do a Step 4...BIG TIME.

Everyone needs a sponsor. You have 9 years and you need a sponsor...without question. The role of a sponsor changes with more time in the program for the person he/she sponsors. At some point, the choices we have in our lives and recovery need to be run past some other GA member, irrespective of how much time there is for either party. Look at this as a 'gut check'. There isn't a single time that I don't feel better after speaking with another GA member. I suppose I could even benefit from those who only look at the Combo Book, as you say is the case in your area, Carol. It would be of tremendous help for me, because I would know with a great degree of certainty that I would NOT want to be like them.

The more time I have in the program, the more I need to bounce things off others. There is no ruling that a Sponsor MUST have more time in abstinence than the person being sponsored. I personally would want more years of experience, strength and hope, but not finding someone like that would not turn me away from latching on to others who could also provide me with such benefits.

Carol...remember, your relationship with other GA members may be equally as important as that of a Sponsor. Maybe you should stop trying to compartmentalize specific people as sponsors and just have a healthy relationship with another GA brother or sister for the feedback and support you and many other people desperately want and need.
