After several weeks of thinking, I have decided to run again for the trustee's job in our Area 5B and I was just advised that I have been elected for the next two years. I was concerned with the rotation principle until I had a discussion in Portland with a more experienced trustee who told me that it was up to the groups in our area to decide if it's time for me to leave or not. So, you will have to cope with me for another 2 years.

Reviewing the Houston agenda, I saw under item 25 that it is proposed to discuss 'continuing or not the Trustee Line due to negative postings and/or lack of use'. I want to take this opportunity to express my opinion on this item about the Trustee Line.

Since June of 2006, there were over 400 postings to the trustee line. It is not, in my opinion, a 'lack of use'. I don't know how many trustees and members read these 400 postings but it surely adds up to several hundreds, if not thousands, of members keeping in touch with the Fellowship through the trustee line. 'Use' of the trustee line is not only posting but also 'reading'.

The item also speaks about 'negative postings'. What is a negative posting? Is it a posting that is opposed to my own vision of a situation? Is it a posting on something that I would have preferred to be kept unpublished? In my opinion, there is no such thing as a negative posting, as long as it is not a personal attack against another member. The trustee line is an open forum allowing trustees and past trustees to express their opinion on a multitude of subjects and allowing hundreds of members to read the postings. In an open forum, there will be postings that I agree with and there will be postings that will rub me the wrong way. If it does affect me, I have to question myself why I am disturbed by the posting and what character defect of mine it is reaching. If the message disturbs, don't kill the messenger.

On several occasions, I was able to better make an opinion on an agenda item after reading postings on it in the trustee line. I was able to see pros and cons of a given situation that would have otherwise escaped my mind.

That is the essence of Houston agenda item 25 and many others on this agenda, all the previous agendas and quite probably all the future ones too. Gary S. has an opinion regarding the Trustee Line that he once referred to as the 'Wash Woman Line'. Evidently others do not agree with him, including me. However, I will defend Gary's right to present that opinion regarding the Trustee Line and any other agenda item. This is not just about Gary's items, but anyone's.

Let's also look at the history of the Trustee Line and understand how the changes to its

structure have caused more meaningful issues to be raised and thrown into the ring for an interactive exchanges of ideas. Originally, the Trustee Line was sent via mail to the Trustees maybe once or twice between Trustee meetings. People put down their thoughts, which weren't always the 'feel good - do good' postings that are being sought with Houston agenda item 25. The problem was that when the Trustees got the mailing, the time between publishing dates made forgetting, an operative phrase in responding to certain items in the next issue, whenever that would be.

Along came the Trustee website and the Trustee Line was reborn. Now we get to do this electronically without any concern for space needed on printed material. Gone are the costs for printing, envelops and stamps, even if ISO paid for everything. Now, the Trustee Line was being published on the 20th of each month. Items would be sent into the website admin and added to the site, but the issue would not be released for viewing until the 20th. No one had any idea what the other people were thinking about until after the issue for that month was posted.

Someone complained about that format saying that the website admin had 'an unfair advantage' in seeing what was posted. Yes, I know, we go from the ridiculous to the sublime sometimes. After that revelation, the current version of the hotline was created. Now what we have is a live document that is opened for submissions on the 1st of each month. All Trustees can not only have their thoughts on any GA relevant issue posted, but any past or present Trustee can respond to a posting just as soon as they have been read. This is what is happening with this subject. I liked what both Andre and Joe had to say and therein lies the basis for what I have written here today.

Regarding Gary's agenda item 25, I will be sure to speak about my opposition to it in Houston, but I encourage others to submit their thoughts about this subject, either pro or con to the Trustee Line for everyone to see. Being a Trustee is about openmindedness. You may think that any agenda item is completely absurd, or you may believe any agenda item is motivated by personalities instead of principles. Whatever the case, please have the courtesy to listen to both sides and then vote your conscience on what is commonly referred to as 'doing the right thing'.
