Like all other things in life, the more things change, the more they remain the same. The Trustee Line was snatched from the jaws of death in the Boston Conference when Denis M. said that he was getting no interest from Trustees, both current and past, to put submissions into each issue. I always disagreed with his style of posting a message in the current issue he was mailing out about when the deadline for the next issue was. My feeling was that everyone is so involved with so many other things in their lives that few would remember those deadlines without reminders. It seemed to me at the time that if we did this via the website and used reminders, we could get a greater level of participation. Remember my comments in Chicago about the Trustee Line? I said that support was dwindling and I was close to saying 'What is the point of continuing this charade?'

So here it is once again...What is the point of continuing this charade?

This Trustee Line is supposed to be about an exchange of ideas in between conferences, either good or bad. It can be used to motivate people, float some thoughts about someone's upcoming agenda item, complain about a process or procedure, say something that has really been a help regarding Trustee issues, or ask for other Trustees' opinions and help. My take on its effectiveness is that we have squandered an incredible asset. Participation is pitiful. There are Trustees who have never put an item in the Trustee Line. Where does that fit in the grand scheme of what the Trustee Line is about? For any Trustee to adopt a 'la-de-dah' approach to this fellowship by saying everything is wonderful is, at least to me, inexcusable. Where are the thinkers? Where are the innovators? Where is the collective consciousness of the group that should be working to improve the program at every possible chance? Why can't we get people to volunteer for committees? Better still, why can't those volunteers to actually do something other than not return phone calls and emails about committee work?

You see, there are numerous things that are wrong with the fellowship, starting with the BOT. We pass things and then look for reasons not to enforce them. We put in a crazy amount of time at these Trustee meetings in the hope of improving things in a substantive way, and we get ... 'make the 3rd word of the 4th sentence of the 5th paragraph on some page in the combo book bold.' I know that sounds harsh, but do we really need to debate such things? These are items that can be done with a mail meeting, or I supposed an email meeting. The thought behind this is to focus our attentions on what will make some positive changes and stop the hemorrhage of structure that allows people to feel they can do what they want in a GA room under the guise of everything being 'self-governing'.

People who don't do their jobs should be called out, plain and simple. If they can't do it or don't want to do it, they should have the sense to step aside. If that doesn't work, they should be told to step aside to let someone else get the job done. We have no accountability to ourselves at these meetings. It is so contradictory that we pass rules when we can't or don't even follow them. Where is that ability to enforce the Guidance Code? Why don't we use that? Why don't Trustees stand up when the Guidance Code is being violated? I have personally done that in the past and have gotten no support because it either wasn't popular, wasn't perceived as important, or because it was just too much trouble to uphold and try to implement the Guidance Code and all the decisions of the BOT, as the Trustee Guidelines state. Did I mention that there are those that say the Guidance Code is just a guide and GA is just a suggested program? How about the ultimate filter of 'Who is it really hurting?' The list goes on.

Sure some people who write to the Trustee Line are pissed off and they have every right to say what is on their mind. We have guidelines for content and as long as there are no derogatory remarks about a member or a room, the submission stands as sent. Is everything that comes out of our mouths supposed to be positive? That's not the way I grew up in this program. If you can't be honest with yourself and tell people how you feel, then where is the validity of the 4th step? I don't sweep things under the rug since

coming into the program. If I think something or someone is wrong, I get it off my chest. If that person wants to take it personally, then it becomes their issue not mine. If that person continues to do the wrong thing then there are other platforms to use, the Trustee Line being one of them. There should be no confusion as to how anyone feels, and hopefully, there should also be less politics. I am often criticized because people don't like my style or delivery. We are not one big happy family, contrary to popular opinion. I do to meetings to continue to refrain from gambling and work on my recovery, not to party it up with everyone before or after a meeting. We are brothers and sisters in a fellowship and we all don't do the right things. One day at a time is cornerstone of the fellowship, but it can derail us from looking ahead in the world of GA business and planning for better things. Some decisions may be uncomfortable for many of the GA members and Trustees, but they will have come from the group conscience and we are duty bound to follow them, irrespective of how popular they may be.

However, this is not how we operate as a generalization. The Trustee Line is the perfect platform for getting rid of the frustration, or for that matter the assumption of hope that something good will come out of a submission. Instead, we hear the deafening silence of a non-responsive group of current and past Trustees. Over 170 people are on the monthly email list for notification of the Trustee Line deadline each month. Our worst month for participation was 10 items in the April '07 edition. We equaled that abysmal performance this month. Our best was the first one we did on the Trustee website with 28 items because it included a brief statement from the committee chairs. I don't think is can be any clearer than what we have here for a great example of apathy; it's called the Trustee Line.

Ask yourself when the last time was that you contacted someone about an agenda item that was posted that you just didn't like. The idea is to let the author know about your problems with the item and to start a dialogue to make a stronger item by modifying it. This feature has been available for the past 9 conferences. In that time, I find it hard to remember when an author of an item tried to change it before the 60 day cutoff because someone chimed in with a suggestion on how to strengthen the item. But, see how many people are quick to rip an item apart when it comes to the floor. One misused word or any small objection can make the item dissolve in an instant and cause to go into banishment for 2 years. Where was the concern and phone call to the author prior to the agenda closing to help modify the item and better insure its passage? Most likely it was in the same place as the Trustee Line submissions from all the Trustees - missing. I have written to people about agenda items that I thought were not comprehensive enough, missing important parts or just the wrong item at the wrong time. Most of the time my emails get ignored because people take it personally. But I took the time to voice my opinion and those people owe me the courtesy of a response, good, bad or indifferent.

We have a lot of issues we ALL need to deal with as Trustee and of course as GA members. I have my demons just like everyone else. One of them is speaking my mind and complaining about others who run through their 2-year Trustee terms like they are on heavy doses of Valium. Too many times we talk about how the Trustees work on tradition rather than clinging to some kind of structure. I believe the Rules and Procedures committee's final report in Portland will be a milestone for the BOT. We need to get used to acting together as Trustees and act uniformly during the Trustee meetings, in addition to the other 361 days of the year when we are not all together. Maybe if we can pick ourselves up by the bootstraps we can pull this fellowship together and not act like independent representatives of the program. I give up 3 days of work twice a year to try and make a difference. The problem is that after leaving the Trustee meeting, it feels like we are in a world of attention deficit disorder; very few of us stay focused on the tasks at hand.

It is my feeling that this is the next to last issue of the Trustee Line. I will send out my usual request next month for submissions for the September 20th issue and do the usual begging for content. In Los Angeles, I will request to discontinue the Trustee Line because of this thing we love so much called apathy. It comes in many other forms, including those who will read the agenda for the 1st time when the Trustee meeting starts on October 4th along with those who will not have downloaded any of the attachments for the agenda.

So whose toes did I just step on with this submission? If only I were a betting man....as the expression goes. I stopped handicapping 19 years ago this coming September 4th.
