As a new Trustee to Area 17, I am looking forward to Tampa and my first Trustee's Meeting. Last year, Area 17 came up with a guideline for managing a GA group's treasury and it was suggested we make this available to all groups. I did submit it to the Tampa agenda and it is under "New Literature up for Merit Vote". Since my experience is limited to Area 17 and we would like to make this available to all Areas, please look over the guidelines and provide any suggestions or additions would improve the guidelines for use in all areas.

Some Areas may disagree with the last sentence in the Current Prudent Reserve Calculation section. If so, tell me the ways you prevent your treasury from getting too large. I can expand that section to include other options. Because group membership can change significantly, our group uses this procedure to keep income in line with our expenses.

I hope you will read over the guidelines and help me make it an effective and useful document for GA groups.

I can't tell you how refreshing it is to see a new Trustee who has not even been to his first Trustee meeting, submit an item for the upcoming Tampa agenda. Most new Trustees find the entire process a bit intimidating, not to mention what they feel like in their first meeting. I would probably say that there are many Trustees who have held the position for numerous terms that still find the process intimidating. It's not a good feeling to have your agenda item shot down, but there is always a reason and a lesson to be learned from a rejection.

Having said that, you are doing exactly what this entire Rolling Agenda process was designed to accomplish 7 years ago, when the online version of the agenda was approved by the BOT - to open up the agenda process and allow other Trustees, both current and past, to reflect their opinions on how to improve the items or what problems they might have with them. As the author of the item, the choice is always yours to accept the suggestions or not, and you can always modify your item up until the closing of the agenda 60 days before Trustee meeting. By the way, that is only the deadline for changing what appears on the final agenda, but it doesn't preclude you from making a different motion during the meeting itself.

I believe it is disgraceful when an item gets overwhelmingly voted down and nobody has previously voiced their disapproval of the item with the author in an attempt to either help the author overcome the objections or simply suggest it be withdrawn from the agenda because of the problems is faces with either its structure, content or unintended consequences.

Every meeting I hear Trustees moan and groan over some of the items on the agendas and talk among themselves during the meetings about how much time is being wasted over a seemingly senseless agenda item. To that end, I say...Where were all of you before the agenda closed? Where were all of the comments on the Trustee Line or to the author directly about the reasons you felt the item would fail and ask that it be withdrawn or help the author modify the item? One very big answer is that most of the Trustees don't even look at the Rolling Agenda before it closes. And to really make things crazy, there are those Trustees who at every Trustee meeting will see the agenda items for the first time when they are actually called to the floor for discussion.

To all the Trustees...

Paul is asking for help in trying to improve his item. The least we can do is tell him exactly how we feel and where it might be improved, if at all. Remember page 17 of the combo book...Get involved and be of service...Do it now.

1. I don't believe the Trustee Meetings are solely for the rich and famous. Many of our members have valuable suggestions to offer, and simply because they can't afford the cost to place an item on the agenda should not preclude them from being able to do so. The agenda is for ALL members who wish to be heard.

2. I would also hate to see some valuable comment unmade because the speaker cannot afford to step up to the microphone.

3. One of the lessons my mentors at the Trustee Meetings have taught me is that I have a responsibility to 'counsel' anyone wishing to add an agenda item; that I am not simply to accept their comments without guidance.
