The majority of our new, interested-in-GA gamblers, are people - as Don as stated - who do not go to a card room, do not necessarily go to a casino - they don't even leave home. They stay in their pajamas and gamble on the internet. The fact that our government tried to shut down gambling sites didn't phase them one iota - they simply moved off shore. We have had high school students beg for help - no one is 'home' to stop them from continuing. It is their own recognition that they have a problem. We have had adults who didn't want to be 'seen' at a casino by family, friends, or co-workers do incredible damage to their finances as well as their self-esteem, and it is the fear of the IRS that has brought them to a GA meeting.

We MUST get off the bump on a log, stop sticking our heads in the sand - and recognize that the computer is definitely the new age of gambling - a closet gambler. If we do not address their issues, we are leaving thousands of potential GA members without dedicated help for their problem. Is that practicing Step 12 - really? Why do we always have to be an 'after the fact' organization; why can't we take the lead and set a good example, as we advise our membership to do?
