The Literature on CD Committee stated they were working on "the twelve steps of recovery" on cd and that they hope dto have this project completed by the summer of 2009. The Literature on CD Committee had no report in Montreal. I am not sure which item this is, as their mission statement states they are only working on approved literature.

The mission statement of the Literature Committee states: To encourage the creation of new Gamblers Anonymous literature as needed and to revise, edit and or update existing Gamblers Anonymous literature. This mission statement does not reflect the work that needs to be done with new literature. Could the fact that no deadlines are in the mission statement have lead past chairmen to loose focus. Or is it that they don't feel they have the right to fix what was submitted, other than gramar.

I have seen a lot of new literature items come up for a merit vote where the concept is great but the item provided needs a lot of work. Trustee should look at what they are submitting as ask themselves if it is ready to print. Maybe a commitee needs to work on it first whether it is a local committee or a BOT committee. We ask a lot of our literature committee when we give them raw work and expect a polished copy in six months, no matter how many items there are.

this is my first time writing on the trustee line, but i need some help and this seems to be the quickest way to get the most input. i seem to be having a problem with people wanting to use their meetings for their own agenda. when it gets out of whack they call me to referee. no matter what i show them in print if it doesn't agree with the outcome they want, i'm accused of being the GA police. principals before personalities (step 12) is only used when it serves them. I realize I am new at this, but I need some assistance. help.

Paulette,

During some of my travels in October, I had the occasion to visit a number of different meetings in different areas. First let me say that I am getting tired of AA mentality governing our GA meetings. There are far to many people that come from the AA side imparting their own agendas on the GA members. Many of AA derivative members have a lot of years of abstinence in GA and they run the rooms the way they want to, without any regard for what the group conscience might be. I have seen rooms where this kind of member chairs EVERY single meeting. Other rooms have this kind of member as the ONLY one allowed to give a comment to someone's therapy. The list is long of how abuses like this continue to undermine Unity Step 1 in so many rooms in the US.

Let's add another component of how these people have no idea what is written in our literature, most notably, the Group Handbook and the Guidance Code. By NOT reading these documents, these members can call the shots in the room anyway they see fit. Most of them bully the rest of the members in the rooms and most just follow what is done because they are too new in the program to know any better.

The bottom line is that each one of these rooms have a very big common problem. None of them had a written format for how business was to be conducted. The members who push their own agendas will fight to prevent implementation of that process, arguing that we don't need any more rules. Actually, those are the rooms that need it the most. One person cannot make the decisions on behalf of the group. ALL decisions regarding the group MUST

be done with a group conscience vote - without exception. Again, I point to Unity Step 1. Don't just read the title, read the explanation of it from the Red Book. The last sentence in the 1st paragraph is quite revealing and supportive of a room agreed upon business format:

---- A group that is troubled due to personality conflicts, indifference to others, individual ambitions, super egos, compulsive talkers, disruptive members and others who openly indicate that group unity is not essential, will certainly be unable to carry our message, and in time the group will cease effectively to exist. ---- If you remember, a very important agenda item for a change in the Group Handbook took place in Montreal. It was for the insertion of a new section for Compiling a Written Room Format. It passed the 1st vote almost unanimously. I hope it meets with equal success in Louisville to have it then be incorporated into our GA approved literature. Here is the link for the attachment from the Download Center of the Trustee website:

Just remember that it is not yet approved literature and cannot be distributed in the rooms.

Bring the room to the point of recognizing that it needs to formulate a written format of how exactly the room should be run and you greatly reduce, if not eliminate the control these people exercise in the rooms.

One more thing. Did you ever stop to think that it is only those people that violate the Guidance Code, the decisions of the Board of Trustees, and the rules of the rooms who complain about those who try to enforce them that scream about that wonderful phrase - 'GA Police'?

Question 18 - The Only Question in the Present Tense

I recently had the occasion to go the ISO office on a project for the Trustee website. This afforded me the opportunity to also attend a Board of Regents meeting, my 2nd since becoming a Trustee, 10 years ago. As they say on TV, that's another show. However, while I was out there, I decided to attend a GA meeting in the area. I really don't know how people in the Los Angeles area deal with the traffic there, but it took me over 70 minutes to go 9.6 miles from my hotel to get to this meeting, when I thought 20 minutes would be enough time. I would have left earlier in the evening, but I had to wait 20 minutes for my car from the hotel valet service.

The meeting was listed on the ISO website with hours from 7:30 -9:30. I arrived at the meeting at 8:30 that evening, knowing that I only had an hour to hear therapies from the attendees and see how the group ran its meeting. I walked into the room and there were members sitting around discussing some business. Seeing a new face, I was immediately asked if this was my 1st meeting. Saying no, I was then told that the meeting was ending and the members were just clearing up some finishing business; however, if I wanted to 'talk' (whatever that meant) to someone after the meeting, I could do that. I responded by saying that the meeting shows up on the website as being open until 9:30, why would it be closing. The answer I got was that everyone had spoken.

WHOA !!!

Fortunate for me, I had attended a meeting in NJ prior to my trip to California and didn't actually 'need' to get to a meeting, nor did I have any pressing issues I had to get off my chest, but I just wanted to attend one. By the way, there is a world of difference in how the meetings are run between the coasts. I know, I know, Unity Step 4, which was why I was curious to attend a meeting in the LA area.

I obviously did not want to ruffle anyone's feathers, but I did not appreciate walking into this meeting and getting treated like that. They knew nothing about me. Didn't ask me if I was under 90 days or when my last meeting was. Didn't ask me if I wanted to make an admission, but asked me to join in with the closing prayers, which I did.

If a meeting is listed on the website, or any other meeting list, to be open from 7:30 to 9:30, then that's what has to happen. Our primary purpose is to help the compulsive gambler who is still suffering. What do we say to a new member who just managed to get the strength to go to his first meeting and gets there at 8:45, 9:00, 9:15, or whenever? I really don't want to have this person find out that his desperate need for help is going to go unanswered. Does question 18 ring a bell with anyone?

If everyone finished with their therapy and wanted to leave, then they should have done so, but at least 1 person has to stay in the room, even if they do absolutely nothing, until the meeting time closure. We can't have this happen to even 1 person. Let me tell you that even with 21 years under my belt, I was affected by this meeting's early closure. I wasn't about to walk out the door and make a bet, but I was asking myself if arguments, disappointment or frustrations create within me an urge to gamble. Why should anyone be brought to that point, when they are seeking help from the very Fellowship that is supposed to help the compulsive gambler who still suffers?

Here is a solution for all groups who currently don't stay open until the advertised closing time. This is what we do in the meeting I call my home group, Westfield Thursday in NJ. Our meeting format - yes a written document arrived at by group conscience that outlines all the procedures we use in the room - shows the meeting open from 7:30 to 9:00. That is generally sufficient time to get everyone in the room to speak. At 9:00 we then do our business and then resume with the meeting until 9:30 or until the last person has spoken, whichever comes first. The expanded time is not advertised, yet we all understand that if we need the extra time, it will be there for us to utilize. We do this specifically in the event we don't get a big turnout on any night. This way, we don't have to sit there until 9:30 if we are done by 8:45 on a slow night. We stay open until the closing time to make sure that the person who might be coming to his/her first meeting late, will have the outlet to find out about Gamblers Anonymous.

I have one better. If we have ended the meeting at 9:00 and we are standing around talking after the meeting and someone comes in while we are still there, a number of us will start a new segment just to accommodate this new person, which includes reading the entire Combo Book, having a few members give therapy again, to get the new person a bit more comfortable, and then go through the 20 questions.

I complain that so many of us are GA members just for an hour and a half to 2 hours a week during 1 meeting, and that there is more to being a GA member. Let us all examine what happens in the rooms we go to and fix this serious deficiency with how we handle the times of the meetings versus their closures. For me, it took all the strength I had to 'crawl' underneath the door of my first meeting. If it had closed before advertised meeting time, I would probably not have come back for another try. I clearly would have in prison, insane or dead by now.

I agree with you, David, wholeheartedly; rooms should remain open if their times are published. Our main purpose is to reach the compulsive gambler who is still suffering and if a room is closed, when it should be open, this potentially could dissuade a suffering gambler from attending not only that meeting, but any other GA meeting as well.

As a result of your comment on the Trustee Line, I was able to raise this issue at our San Diego Inter Group meeting, and the heads nodded in agreement and it was vocally agreed - that at least one person MUST stay to help the 'unexpected guest.' On Thanksgiving, the temple which houses our Thursday night meeting is closed. But those of us who choose to gather together, go to a local restaurant for coffee and comraderie in support of one another. However, a volunteer stays at the temple in case a new-to-program person arrives, they are advised where the group is meeting. We have had many 'newcomers' arrive and enjoy the company and those who do ALWAYS come back to the next meeting; they feel welcomed.

In San Diego - we NEVER completely close; there is always an alternative. During the Holidays - we began and support a 'marathon' meeting which goes from 10:00 p.m. until 7:00 a.m. on Christmas Eve and New Years' Eve - so that anyone with any addiction who may be in pain or discomfort has a place to go - in lieu of a casino, or a bar, or a drug house, etc. These collectively seem to be the most difficult of times for anyone with an addiction, and it's comforting to know they can enjoy the company of others with the same problem(s). Volunteers rotate and chair meetings; volunteers bring food, coffee, donuts, snacks - whatever they have - for all to enjoy. It has become an amazing success in our community.

I think this only proves that there is always a need for a meeting. Addiction does not take a 'holiday,' or 'time off.' Arguments, disappointments and frustrations DO create within us an urge to gamble. It belongs in the present

tense.

I was just about to write a scathing note supporting your position about a person in a profession not being allowed to speak to a GA open meeting. We had a similar 'situation' surface here in San Diego. Obviously, the speaker has an outside GA 'agenda.'

However, I said to myself, "Self, you'd better look that up in GA materials." So, I referred to our Red Book, "A New Beginning," and on page 11, it refers to "Open Meetings." The final two sentences of that paragraph state, "Sometimes open meetings have invited guest speakers. These speakers can be Gamblers Anonymous or non-Gamblers Anonymous members."

Ouch! What that paragraph does not make clear - or those sentences either -

is whether or not these guest speakers can be from any professional venue. One of our room guidelines is that there can be 'no solicitations of any kind.' But by offering a guest speaker the opportunity, is that not tantamount to endorsing the ABC Insurance Company, or the ABC psychiatric association. If our own GA members can't solicit for their own businesses, why should an outside speaker enjoy that privilege and violate our own room guidelines? Is an agenda item needed here to make that paragraph or sentence clearer?

For years I think we have 'assumed' that the sentence means Gam-Anon or family members can speak - I'm not sure I adhere to allowing ANY outside non-GA person speak. I'm interested to know if anyone sees the other side of the coin here??? I know some groups allow priests, rabbi, or other religious speakers talk - but do we need some 'restriction' here - or is it wide open?

Selling literature at Intergroup

I was discussing with a fellow member if it would be possible for an Intergroup to sell literature above the cost that it pays for it from the ISO, to it's meetings that attend? The answer was, we didn't know, so let's put it on the Trustee Line and see what other people feel about this, thus this new subject. I don't know if this violates anything in our literature, but I would be interested to find out, and what your opinion is on this. Steve: I contacted our Literature Chair regarding our procedure, and after some careful analysis of shipping costs and sales tax, he and our Budget Committee recommended (with our vote of approval) we add @10% of the cost of the piece of literature - to the ISO sales price - which covers both shipping

and taxes. In that manner, we can save our group representatives some expense, while not completely absorbing the other costs by our Inter Group.

We created our own 'literature order form' (with the increase added) that group reps can pick up at Inter Group meetings; fill out; and turn into the Literature Chair, with the exact change in an envelope. He gathers the literature order and passes it out to the groups during the meeting. Literature not available, for whatever reason, is refunded at the same time. (This order form is also on our website. Groups are encouraged to fill this out ahead of time. That way both the Treasurer and Group Rep know what amount of money is going to be expended on the group's behalf.)

Groups who choose to order directly from the ISO Office are free to do so, but the majority, if not all, order from our Inter Group to save money. We also have a system in place to cover emergencies, i.e. pins and medallions forgotten, etc.

If a group orders directly from the ISO, they would have to pay shipping AND sales tax themselves for their entire order. If you have other questions regarding our approach to GA literature, or our system, my phone # is on the Trustee Listing and I would be happy to answer any questions you have or direct you to our Literature Chair.

I hope this helps to answer your direct question.
