New meetings in an area represented by an Intergroup

12/1/09 - 12:01 AM Greetings, Everyone,

We here in area 13 have had 2 incidents of concern recently regarding new meetings in our area.

The first involves a 'New Meeting', which has apparently been in existence since January, 2009. We (intergroup) learned of the meeting when they asked to join our Intergroup in September. We have 3 trustees, yet none of us were notified of this meeting starting.

The second involves a member with barely 90 days. This member told our Intergroup Chairman that he plans to start a new meeting, and had already received a starter kit from I. S. O.

Some of us believe there is something wrong with this picture. First, since there don't seem to be any restrictions on who can start a meeting, theoretically, a member with a couple of weeks (or less) in the program could start a meeting, then end up having an influence over even newer members who found the new room. Doesn't this sound like 'the blind leading the blind'? Also, since our Guidance Code says that the Intergroup should publish a meeting list for the area, it gives the impression that the Trusted Servants of Intergroup encourage members to attend. (I know, in an ideal world senior members would 'pitch in' to help the new meeting get going initially; however, in the real world, if the senior members didn't believe the new meeting should even have been started, they would not be inclined to attend.)

Points for discussion:

My Intergroup believes that there should ideally be SOME requirements for a member to start a new meeting. We don't expect or want the requirements to be prohibitive, but we'd like to ensure that the person requesting the new meeting has some experience with recovery. Also, since we are expected to advertise the new meeting, we believe that the request for a starter kit should come from the area Intergroup.

Guidance Code; page 4, Article VII, Section 1.

Current version: "Whenever two or more persons with a desire to stop

gambling meet together on a regular, weekly scheduled basis to discuss their gambling problem, they will be known as a group, only if they commit themselves to follow Gamblers Anonymous' Guidance code and limit their use, display and distribution to only approved and appropriate Gamblers Anonymous literature. They are also to notify the International Service Office (I.S.O.) of their existence".

New version: Whenever two or more persons with a desire to stop gambling meet together on a regular, weekly scheduled basis to discuss their gambling problem, they will be known as a group, only if they commit themselves to follow Gamblers Anonymous' Guidance Code and limit their use display and distribution to only approved and appropriate Gamblers Anonymous literature. Any member/S wishing to start a new meeting in an area represented by an established Intergroup, should notify the Intergroup Chairperson, who will request a starter kit for the new meeting from the International Service Office (I.S.O.), and the starter kit will be sent to a Trustee from that area. For a new meeting in an area not represented by an intergroup, the member/S wishing to start a new meeting should request the starter kit through their area Trustee, and the starter kit will then be sent to the Trustee. If possible, at least one of the members starting the new meeting should have a minimum of one (1) year of abstinence.

I would appreciate feedback on this topic.
